



## Stillwater County Facility Rentals - Fee Schedule

Approved by Stillwater County Commissioners

The sliding benefit scale provides the formula for establishing the fee schedule for the use of the Stillwater County Fairgrounds / Civic Center. Rates are lower for those uses and activities that have a broad community benefit. Rates are higher for activities that are directed toward individual benefit or commercial activities.

SC non-resident	These rates apply to all individuals and business located outside of Stillwater County		
SC resident and business	These rates apply to all Stillwater County residents and businesses.		
SC community non-profit	These rates apply to non-profit groups, 501(c)(3) status for civic purposes.		

**Step 1:** Identify the rate category which apply to the party submitting the application.

**Step 2:** Enter the appropriate rate for each facility, service, or equipment. **\*\*The special use fee is charged for events over 300 persons and includes janitorial service during event hours.**

**Step 3:** Enter the number of units requested for each item identified in Step 2.

**Step 4:** Enter the deposit required for each item identified in Step 2.

**Step 5:** Write separate checks payable to Stillwater County for total fees and deposit required and return with completed application forms. Events will be booked only when all forms and payments are received.

**Cancellation Policy** - All scheduled events cancelled less than 30 days from the event forfeit deposit.
