SUBJECT: SUMMARY OF PUBLIC OPINION SURVEY RESULTS

From October 7 through the end of the month, the County opened a public opinion survey to help gather and solicit comments from the public on the facilities and capital improvements discussion. The survey availability was discussed at each of the seven community meeting held around the County, and was made available online through SurveyMonkey and as a hard copy. 160 responses were collected. Results of the survey are discussed below.

Question #1: Stillwater County needs new County office space:

Respondents overwhelmingly agreed with this statement, with nearly 69% stating they agreed or strongly agreed with the statement. About 15% said they disagreed or strongly disagreed.

Question #2: Stillwater County needs new fairgrounds/event center facilities:

This statement also saw wide support, with about 2/3rds of respondents saying they agreed or strongly agreed with the statement. However, about 25% said they disagreed or strongly disagreed. In fact, this statement had the highest level of strong disagreement on the entire survey.

Question #3: Stillwater County needs new court/law enforcement facilities:

This statement had a large amount of support as well, with about 64% of respondents agreeing or strongly agreeing.

Question #4: Stillwater County needs to preserve the current courthouse:

This statement had some of the most support on the survey, with nearly 75% reporting they agree or strongly agree with the statement, including over 40% saying they strongly agreed with the statement, the 2nd highest instance on the entire survey.

Question #5: Stillwater County needs a new library:

This statement had some of the most striking disagreement on the survey, with strongly agree, agree, neither agree nor disagree, and disagree all being chosen by more than 20% of respondents. A plurality of respondents reported they strongly agreed with the statement, a result also shown by the amount of open-ended responses that mentioned the library, but this was one of two questions that failed to gather agree/strongly agree of more than 50%, with nearly 28% reporting some level of disagreement.

This statement had more agreement in the Columbus area, with over 53% agreeing or strongly agreeing with the statement, compared to less than 43% from respondents in other communities.

Question #6: Rank the following (new County office space, new fairgrounds/event center, new court/law enforcement facilities, preserving courthouse, new library, none of the above) in the order of importance:

New County office space ranked first in this question, with a weighted score of 4.71 and nearly 38% of respondents ranking this as the top priority. New court/law enforcement facilities was 2nd at 4.12, followed closely by preserving the courthouse at 4.10. Preserving the courthouse had the 2nd most top priority responses, while new court, law facilities had the most 2nd and 4th priority rankings, and the 2nd most 3rd priority rankings. New fairgrounds/event center had a score of 3.96, with new library at 3.33. New library was ranked 5th priority by the most people by a wide margin. None of the above was only ranked by 41 respondents, with over 70% of those ranking it last.

This question also saw some differences between respondents from Columbus and those in other communities. Respondents in the Columbus area scored new office space at 4.64, compared to 4.81 in other communities. New court/law facilities was nearly identical with 4.12 from Columbus compared to 4.13 elsewhere. Preserving the Courthouse scored at 3.96 from Columbus versus 4.27 from other communities. New fairgrounds/event center was also very similar at 4.00 from Columbus and 3.96 from other communities. New library scored significantly higher from Columbus at 3.66 than from the other communities at 2.78.

Question #7: Stillwater County is doing an adequate job at allowing for economic development:

This statement had the highest level of disagreement and the lowest level of agreement, scoring just about 30% at each. It also had the highest level of neither agree nor disagree at nearly 40%. This may be attributable to a lack of understanding of what economic development is, the nebulous nature of economic development in general, and/or the County's Economic Development Coordinator position being unfilled at the time of this survey.

Question #8: The land north of the Interstate would be a good location for a new fairgrounds/event center:

This statement garnered agree/strongly agree from nearly 56% of respondents, with nearly 24% reporting they disagreed/strongly disagreed with the statement.

Question #9: The current fairground area would be a good location for new County offices:

This statement had support from nearly 53% of respondents. About 20% reported disagreement, with nearly 27% stating that they neither agreed nor disagreed with the statement. Columbus-area

respondents agreed/strongly agreed with this statement at 48.5%, with nearly a quarter disagreeing/strongly disagreeing. In contrast, respondents from other communities agreed or strongly agreed with this statement by over 60%.

Question #10: When considering facility planning, the County's focus should be on (planning for future growth, creating opportunities for economic development, addressing current deficiencies, improving/streamlining service, improving existing facilities, fiscal sustainability, consolidation of County-owned buildings):

Addressing current deficiencies was the most selected option with almost 68%, followed closely by planning for future growth with 64%. Fiscal sustainability had just over 58%, and creating opportunities for economic development was the only other option with more than 50%, at about 53%. Improving existing facilities had just more than 42%, consolidation of County-owned buildings had a little more than 40%, while improving/streamlining service was just under 38%.

Columbus area respondents ranked addressing current deficiencies (68.32%), planning for future growth (68.32%), fiscal sustainability (65.35%) and creating opportunities for economic growth (57.43%) as the highest, with other options not topping 50%. Respondents from other communities, however, only selected addressing current deficiencies (65.52%) and planning for future growth (55.17%) above 50%.

Question #11: How often do you use the Fairgrounds facilities?

This question shows that respondents don't necessarily use the fairgrounds often, but a significant amount do utilize the facilities. At least once a week (2.55%), once a month (6.37%), and once every other month (5.10%) were the three least selected responses. However, over 41% stated they use the fairgrounds 2 or 3 times a year, by far the highest response. Altogether, over 55% of respondents reported they use the fairgrounds facilities multiple times a year, with another 16.56% saying they use them once a year. Nearly 20% stated they use the fairgrounds facilities less than once a year, and over 8% said they never use the fairgrounds.

Columbus-area respondents reported more frequent use of the fairgrounds, with 63% reporting they use the facilities multiple times a year, compared to less than 44% of respondents from other communities.

Question #12: How would new fairgrounds/event center facilities impact your use?

Nearly 65% of respondents stated there would be no change in their use, while about 1/3rd said their use would increase. Less than 2% of respondents said their use would decrease. This is especially interesting in light of Question #2, in which about 67% of respondents agreed with the statement that the County needs new fairgrounds. The difference in an apparent desire for improved facilities with an anticipated increase in use may be to programmatic unknowns, or evidence that the current facilities are sufficient other than some necessary updates.

Question #13: Stillwater County residents would benefit from having County services consolidated on one campus:

This question had strong agreement, with nearly 73% signaling that they agree/strongly agree with the statement. However, the responses to Question #10 show consolidation of County-owned

buildings to be a relatively low priority when weighed against other factors. One explanation for this may be that County residents would generally support consolidation of services, but are used to a certain amount of decentralization.

Question #14: There will be an economic benefit to Stillwater County in providing multi-use facilities that can be used year-round:

Over 70% of respondents reported they agree/strongly agree with this statement, including about 41.5% saying they strongly agree, the highest instance of that response in the survey.

Question #15: Which community do you live closest to?:

Respondents were spread throughout the County, though over 62% reported they were from the Columbus area. Two respondents said they own land but do not live in the County. The survey results were also broken out by Columbus-only responses and other communities within the County to show potential regional differences.

Question #16: Are you male or female?:

Females made up over 61% of total respondents. However, Columbus-area respondents with nearly 70% female, while respondents from other communities we almost 53% male.

Question #17: What is your age?:

Respondents were typically older, with almost 32% reporting they were 65 or older and 23.5% 55-64. The only age demographic that did not have a response was Under 18.

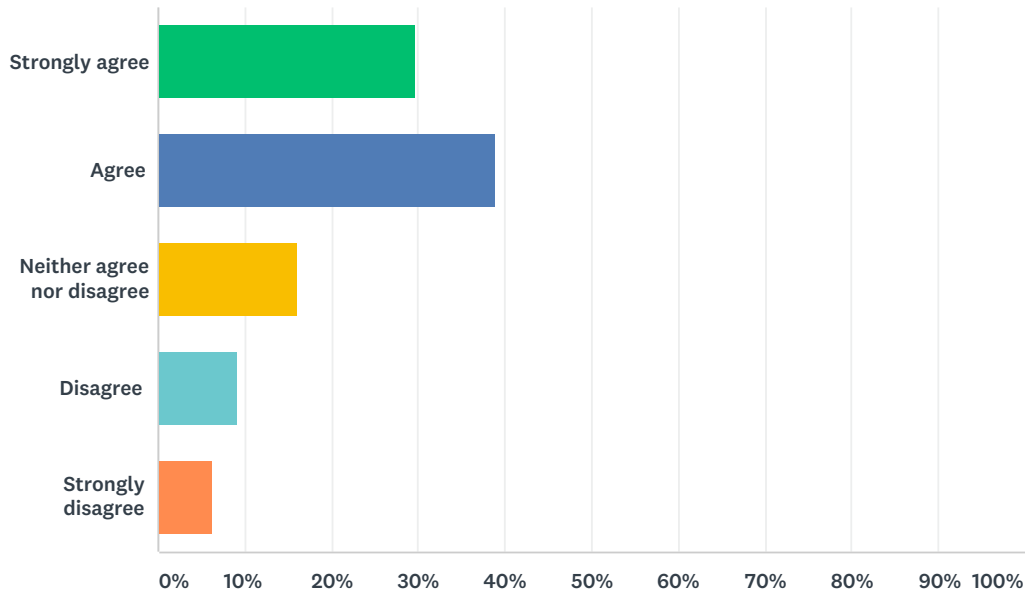
Question #18: Is there anything else you would like to tell use?

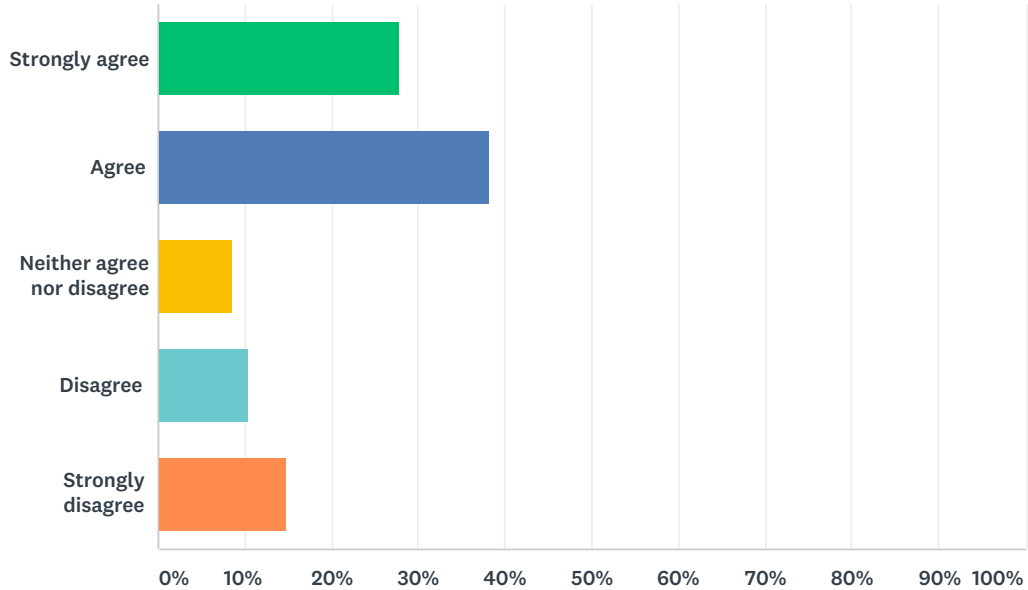

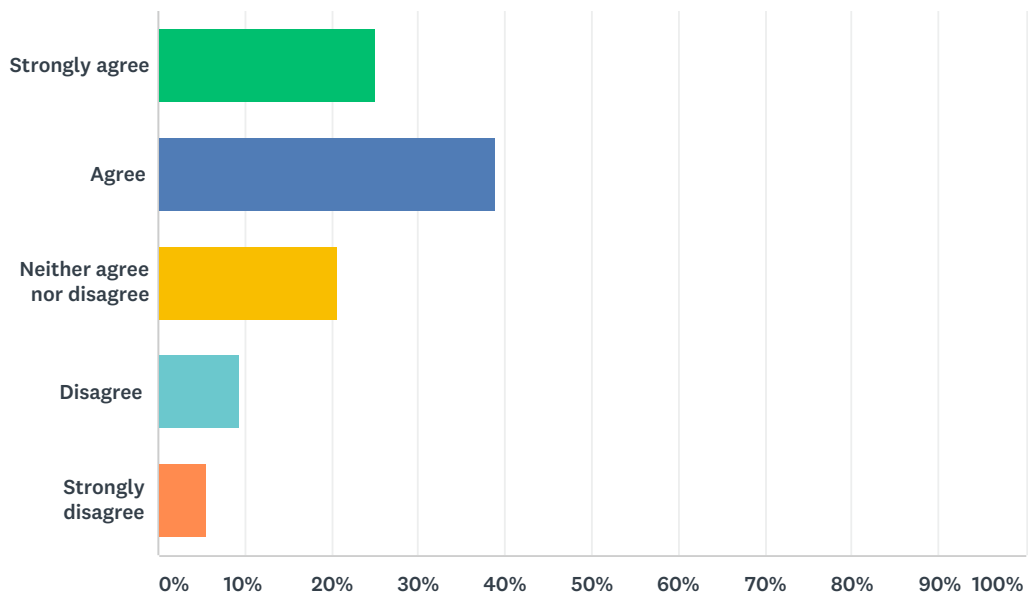

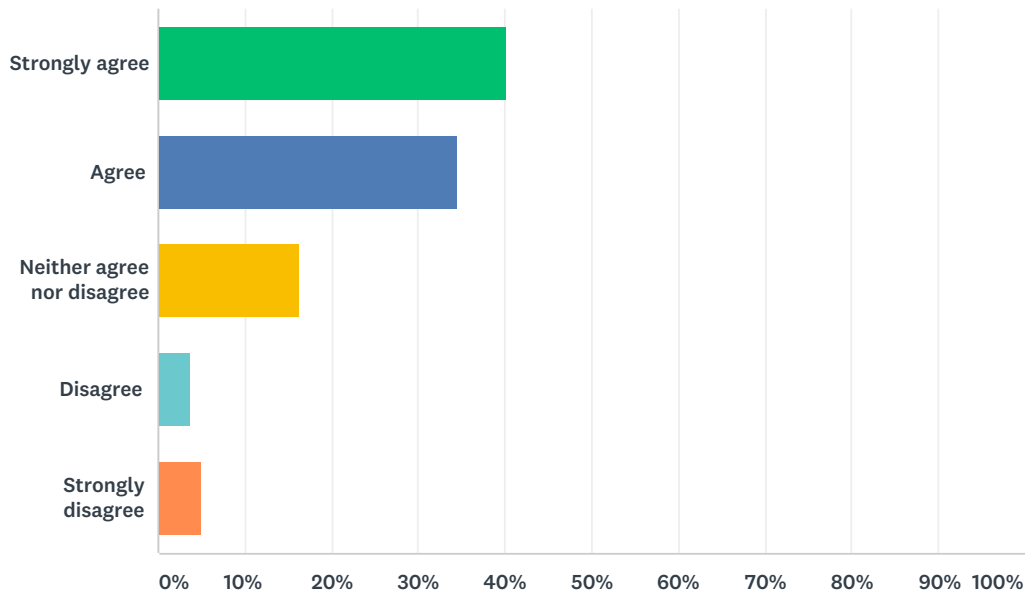

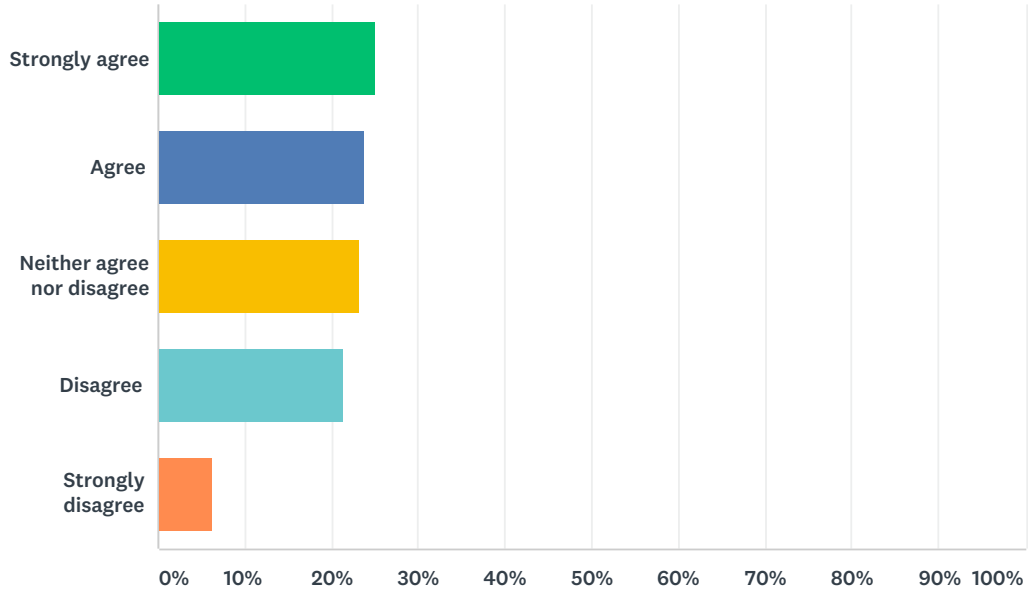

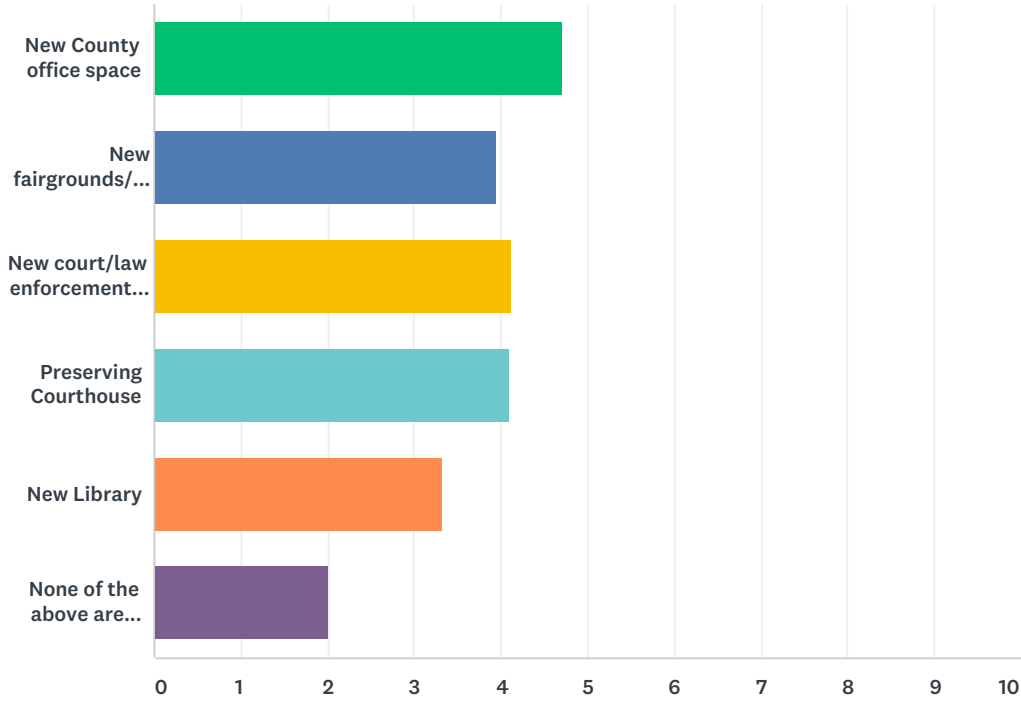

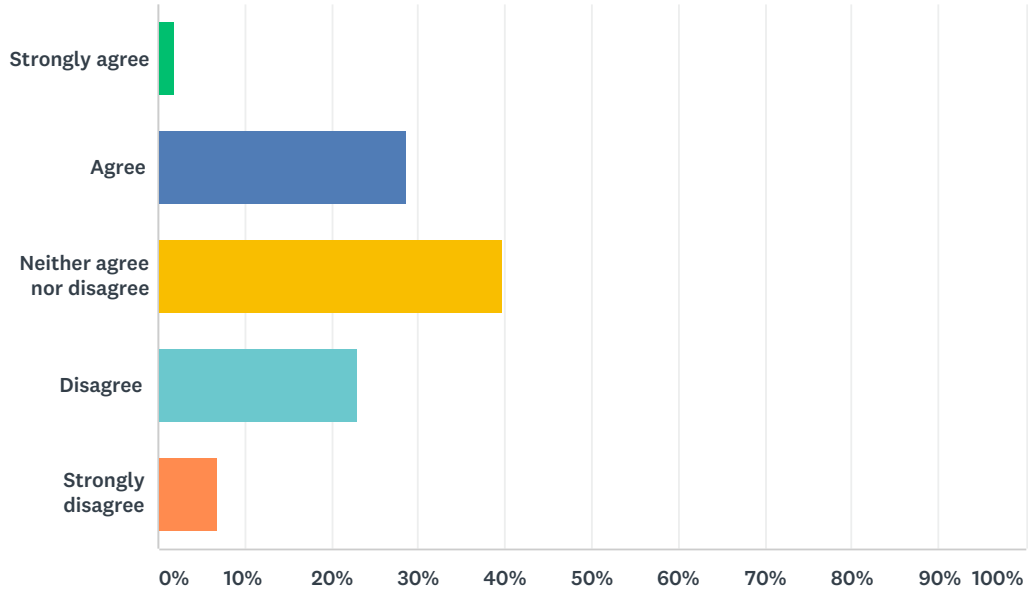

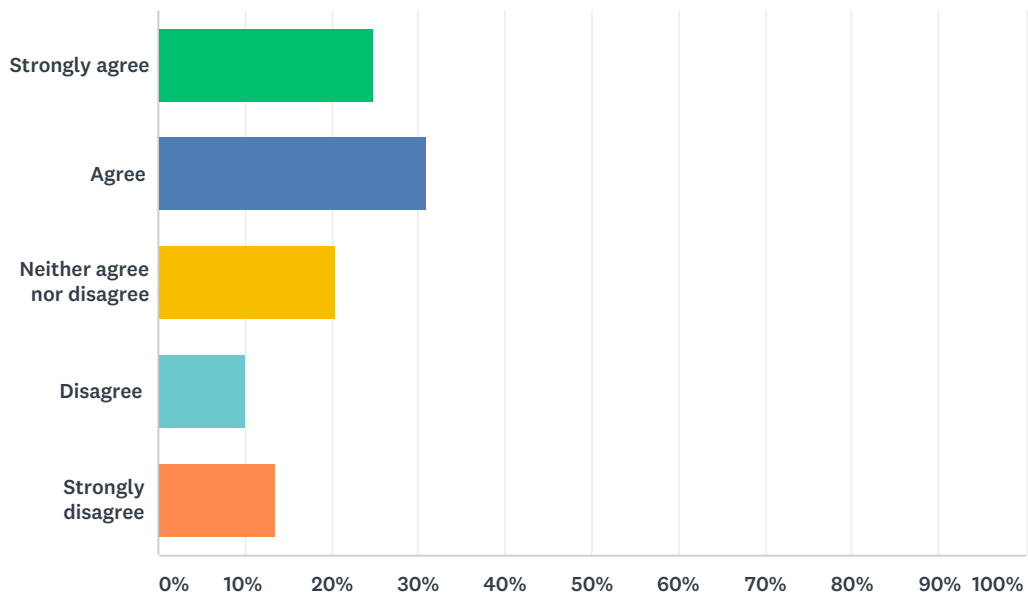

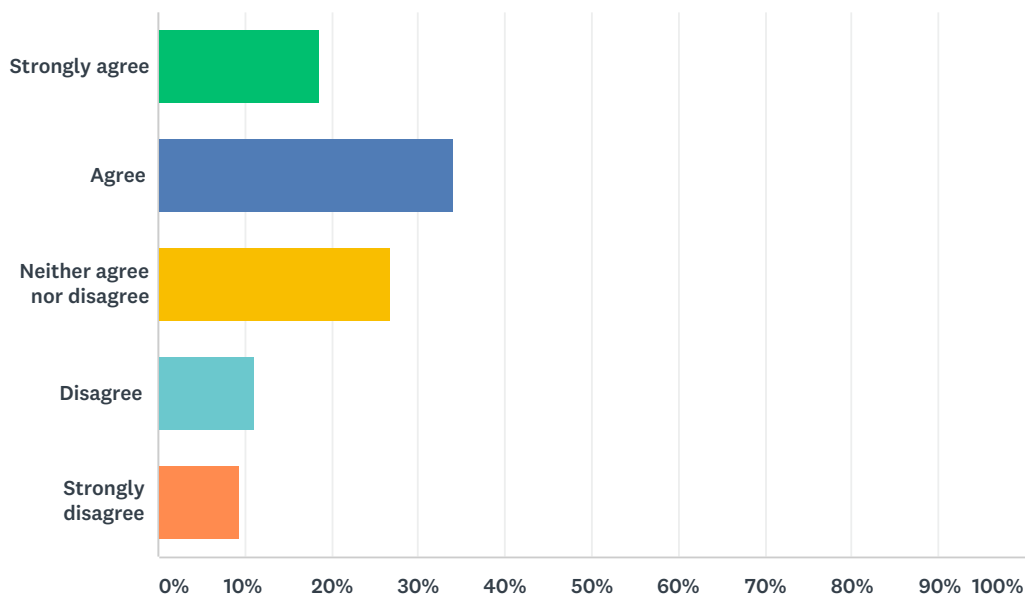

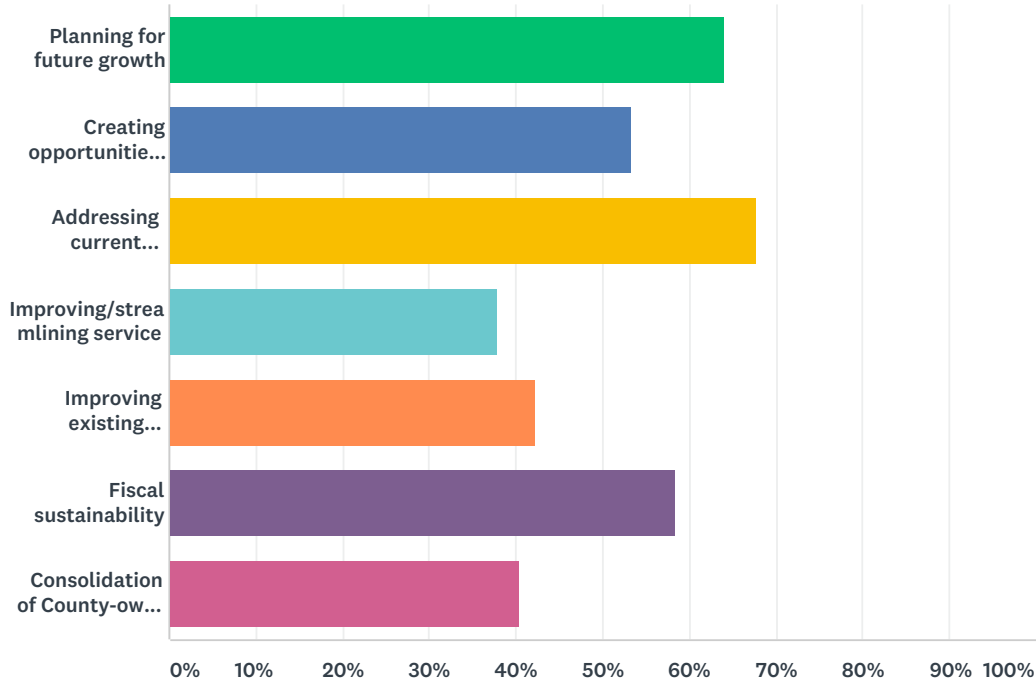

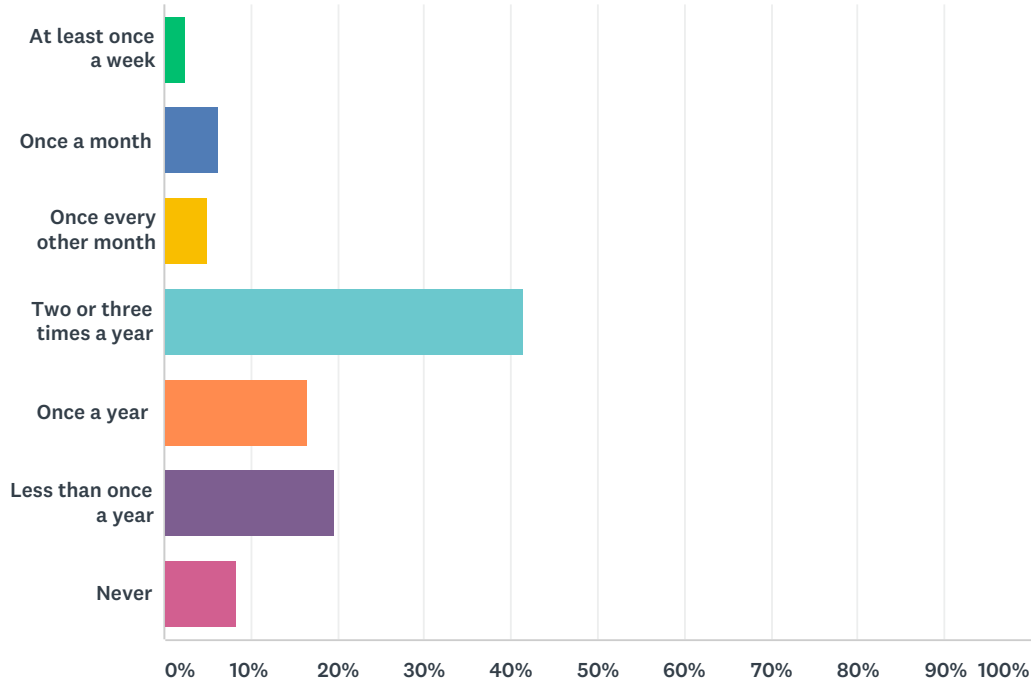

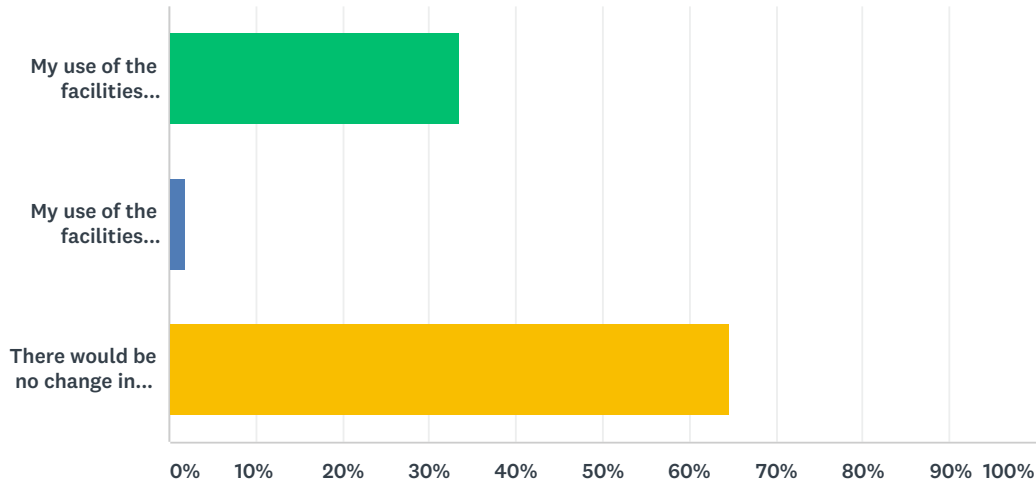

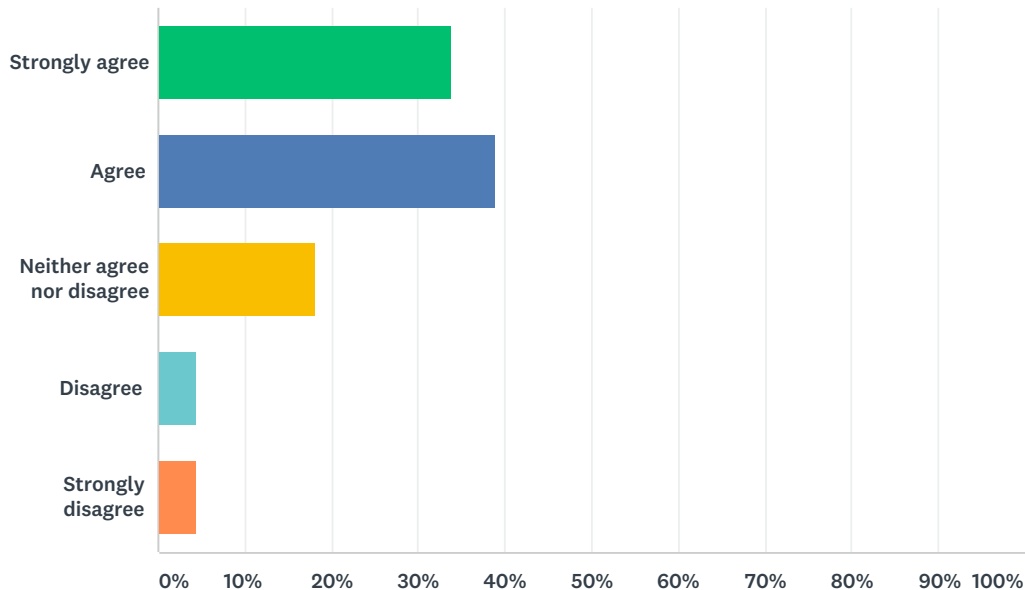

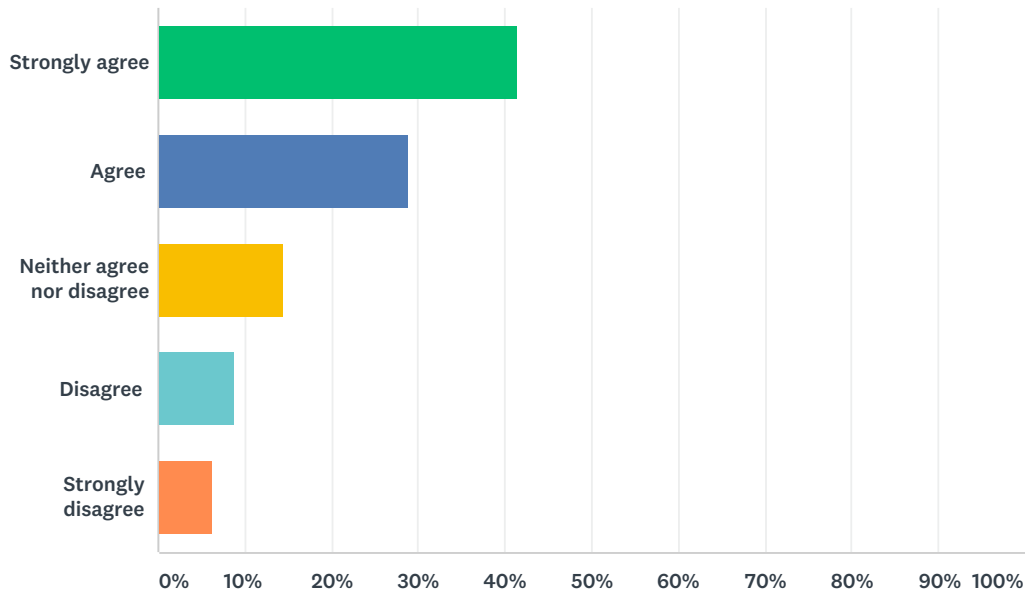

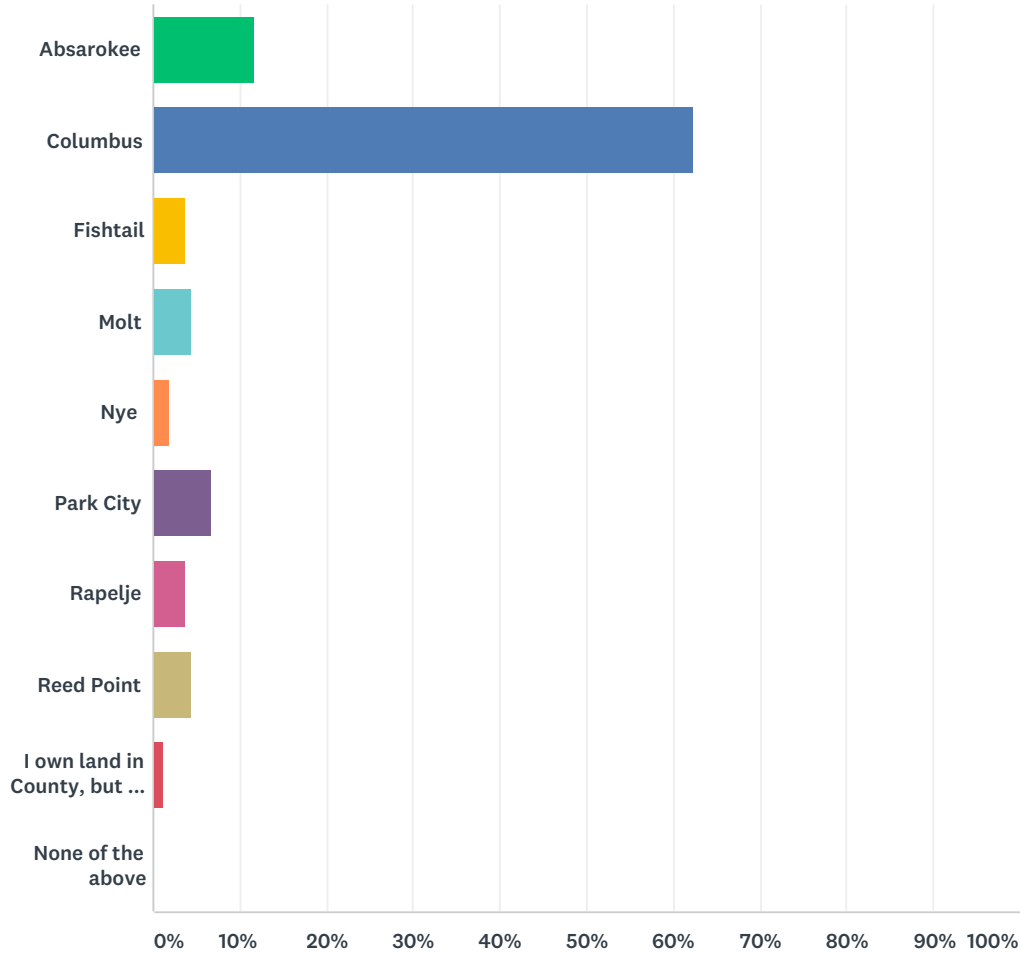

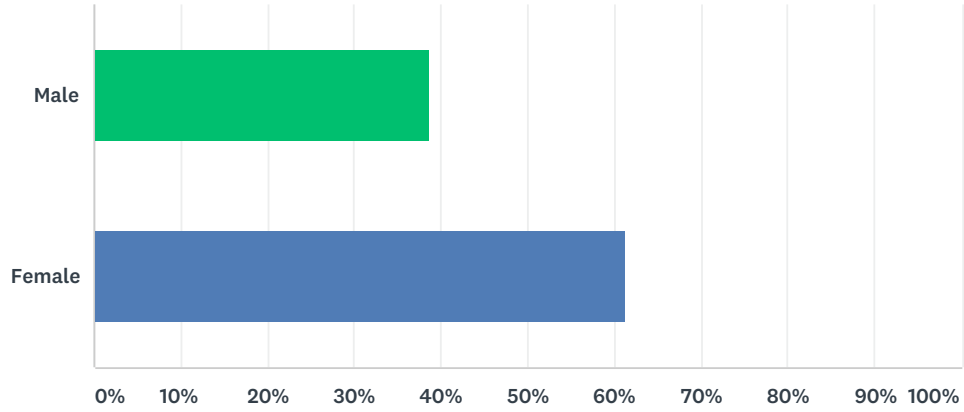

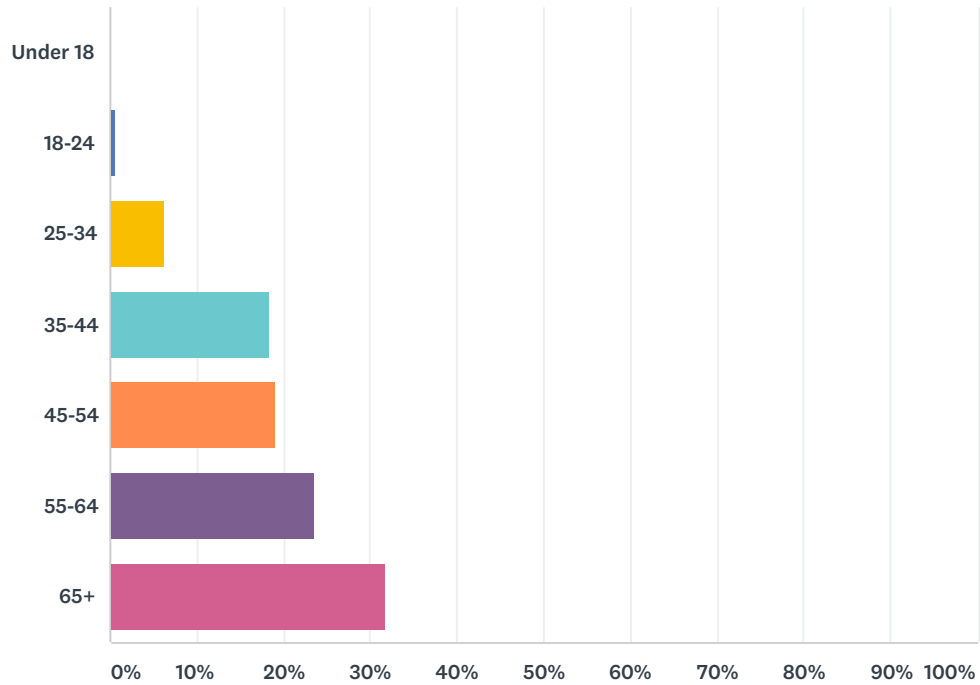

On the courthouse retention: The present courthouse is the only substantial public building in the county, and fortunately it presents both a feel of the dignity and necessity of government as well as its historic roots. And I have heard several other people say this same thing--I believe that the grounds to the south of the courthouse really give it its stately feel, so please, please retain both the courthouse, especially its outside aspects and its grounds to the south. Additionally when planning the remodel of the interior I would like to see some of the early 20th century feel restored to at least the central core of the interior, outside the offices and courtroom. Other issues: I believe the thoughtful planning of a fairgrounds/events center is the most visionary part of this public buildings expansion. In particular, the events center can turn into a center of activity that helps bring economic growth to the county. I am in my 70's and it seems to me that Columbus has largely been stagnant for 40 years or more. True, there have been some major businesses bring economic benefit to the county, e.g. Sibanye Stillwater Mining Co. and Montana Silversmiths as prime examples. But even with those additions, and the activity near the I-90 interchange, Columbus pales beside Livingston and Laurel, both of which have grown in terms of service businesses, housing, and population relative to Columbus. I think Columbus should be the business driver for the county and for a wide stretch of south-central Montana, a role that is only nodded to at present. Both growth planning and economic development have been pursued by the county in only a pro forma way--look at the bare-bones recent county growth plan, and the lack of a consistent economic development program. The new center with fairgrounds and planned event center are a good first step to changing the status quo. I also like the idea of an expanded library from the small facility in downtown Columbus. One way to generate public enthusiasm to pursue new directions is to provide a location for civic engagement. A library with sufficient conference room space for small (10-15 people) to medium (say 45-60 people) gatherings, along with a place to be able to access source materials like a library provides, I believe would add vitality to Stillwater County.
