A RESOLUTION AMENDING THE SOLID WASTE POLICY 8.00

WHEREAS, MCA 7-6-4013 is clear that fee increases require a budgetary hearing process per MCA 7-1-2121, involving the Commission; and

WHEREAS, the cost has increased for hauling solid waste to the City of Billings landfill; and

WHEREAS, the Solid Waste Board recommended amending Policy 8.00 Rate Schedule/Commercial Rate Schedule to include pallets; and

WHEREAS, the Solid Waste Board recommended amending Policy 8.00 Rate Schedule/Commercial Rate Schedule to increase commercial yard debris, grass, branches; construction debris; carpet; passenger & light truck tires; passenger & light truck tires with rims; truck tires; truck tires with rims; cut up tires; barrels (not cleaned); and

WHEREAS, a duly advertised public hearing for the additions and increases *Amending Solid Waste Policy 8.00* was held on August 28, 2018, for public input.

NOW, THEREFORE, BE IT RESOLVED, that, after giving due consideration to the results of the hearing, the Commission hereby approves the **additional fee** as follows and shown in Exhibit A:

Pallets	\$2.00 each or \$12.00 per cubic yard (6 = cubic yard)

BE IT FURTHER RESOLVED, that, after giving due consideration to the results of the hearing, the Commission hereby approves **increasing fees** as follows and shown in Exhibit A:

Commercial Yard Debris, grass branches	\$10.00 per cubic yard
Construction Debris	\$17.00 per cubic yard
Carpet	\$10.00 per cubic yard
Passenger & Light Truck Tires	\$5.00 each
Passenger & Light Truck Tires with rims	\$10.00 each
Truck Tires	\$10.00 each
Truck Tires with rims	\$15.00 each
Cut Up Tires	\$5.00 per cubic yard
Barrels (not cleaned)	\$10.00 each

BE IT FURTHER RESOLVED that this resolution become effective immediately.

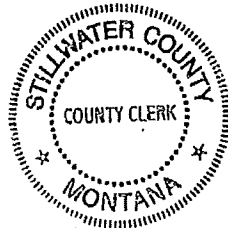
