WHEREAS, the County planning staff has prepared a Stillwater County Growth Policy and held public meetings throughout the County to discuss the Growth Policy and to receive public input; and

WHEREAS, the Stillwater County Planning Board, as required by MCA 76-1-602, conducted a duly advertised public hearing on the proposed Growth Policy on October 3, 2018; and

WHEREAS, the Stillwater County Planning Board, as required by MCA 76-1-603 passed a resolution recommending to the County Commissioners that the Growth Policy be adopted; and

WHEREAS, the County Commissioners of Stillwater County, Montana wishes to ensure the public has ample opportunity to provide comment on the draft Growth Policy.

NOW, THEREFORE, BE IT RESOLVED, that the Stillwater County Commissioners will accept public comment on the draft 2018 Stillwater County Growth Policy for 30 days beginning on this date.
